- BBL Transportation LLC's receiving terms are 30 days upon invoice date. A finance charge of 20% annum will be added to accounts 60 days past due.
- Company adheres to brokerage agreement, that BBL Transportation LLC is responsible for freight to be transported as a third-party carrier and shall not be placed on any documents as the delivering carrier.
- BBL Transportation LLC operates with carriers under contract maintaining a cargo and damage liability in the amount of \$75,000 per shipment. Any load valued above this amount will not be recognized unless notified in advance, to arrange for an increase in insurance.
- Failure to provide BBL Transportation LLC pertinent information regarding freight outside of these parameters will result in freight only being insured up to the valued amount of \$75,000 that BBL Transportation LLC provides.
- LTL shipments are based off estimates of what the carrier will provide. There is no set date and time that material will be shipped or delivered, if a delivery is needed by a specific date and time, please give advanced notice so that BBL Transportation LLC can arrange for proper handling of material.
- LTL will be held to the amount it was quoted at unless there are changes made to the lane, pallets, dimensions, weight or class. If these changes are made it may reflect on the cost of the shipment.
- LTL shipments will be classed by an estimate unless provided with an NMFC number for classification. If incorrect class number is given to BBL Transportation LLC, additional charges may apply.
- Accessorial charges may apply for specific notes to LTL shipments (appointment time, lift gate, weight, class, etc). If these charges do apply, BBL Transportation LLC will notify you of the change immediately.
